It is strictly the responsibility of the user to ensure that equipment is installed by properly licensed professionals in accordance with all Federal, State and local Laws, rules, regulations and building codes.

Plans of the grease removal system must be submitted to and approved by the Narragansett Bay Commission prior to installation of the system.

Grease Removal Units

The following is a list of grease removal unit (GRU) manufacturers and their local representative. These GRUs recover and remove oils and grease electronically and mechanically from the effluent wastestream. The oils and grease recovered can be recycled or disposed of in solid waste. Manufacturers report that these GRUs significantly remove Total Suspended Solids (TSS) and Biochemical Oxygen Demand (BOD) and report removal rates of 96% to 99% for oils and grease.
